




All-of-Government Approach to EJ

- Update and revitalize EO 12898
- Accountability through performance metrics and annual reporting on success
- Drive interpretation of existing agency authorities to further incorporate EJ

Expanded & Targeted Enforcement

- Create Environmental and Climate Justice Division, U.S. DOJ
- Reform Title VI Enforcement and EPA's External Civil Rights and Compliance Office


Expanded Monitoring & Reporting

- Require more fenceline monitoring for publiclyavailable real-time data
- Release Climate and Economic Justice Screening Tool
- Dispatch Environmental Public Health Corps

Empowering & Investing in Communities

- Create Interagency Climate Equity Task Force
- Target 40% of investment in clean energy to benefit disadvantaged communities
- Give preference in competitive grant programs
- Fund infrastructure and remediation


Other Potential Biden Administration EJ Actions and Priorities

Biden Administration likely to continue bringing these issues together in all-ofgovernment approach







Voluntary Industry Action & Corporate Social Responsibility

Increased interest in private sector in EJ, beyond addressing compliance requirements

Increased demand for ethical practices by consumers, investors, and regulators

EJ just makes good business sense from a risk perspective to reduce

- Costly Delays
- Legal Challenges
- Reputational Harm



Key Takeaways

The Biden-Harris Administration will prioritize environmental justice, seeking transformative change across the federal government.

States are expected to continue advancing the ball with respect to EJ legislation and enforcement, especially with federal support

Globally, environmental justice themes – if not explicit terminology – will likely become more common.

Industry actors may seek to voluntarily incorporate environmental justice into expanded CSR programs to meet growing consumer, investor, and government demand.
