- Predicting and communicating weather forecasts;
- Planning and managing Earth-observing satellite systems;

- **Environmental and Natural Resources** (e.g., National Environmental Policy Act, Endangered Species Act, Marine Mammal Protection Act, Coastal Zone Management Act, National Marine Sanctuaries Act, Magnuson-Stevens Fishery Conservation & Management Act, etc.)
- Administrative Law and Other Federal Statutes (e.g., Administrative Procedure Act, Freedom of Information Act, Privacy Act, etc.)
- Maritime and Admiralty Law (e.g., maritime heritage, preservation of shipwrecks, etc.)
 - **Tribal Law** (e.g., tribal treaty fishing rights, Alaska Native subsistence use, tribal consultation, etc.)
- **International Maritime Law** (e.g., U.N. Law of the Sea, international fisheries management treaties, International Convention for the Prevention of Pollution from Ships, customary international law, etc.)
- **Trade and Commercial Law** (e.g., World Trade Organization agreements, free trade agreements, Tariff Act of 1930, Dolphin Protection Consumer Information Act, etc.)
- And more! (e.g., Weather Service Organic Act, Land Remote-Sensing Policy Act, National Historic Preservation Act, Coast and Geodetic Survey Act, etc.)

What do we do in NOAA OGC?

- NDAR
- Interpret existing statutes and provide technical drafting assistance on pending legislation
- Review and provide advice in drafting regulations
- Support natural resource damage assessments and restoration (e.g., Deepwater Horizon, Hudson River restoration)
- Aid international treaty negotiations
- Charge civil environmental violations and assist in civil and criminal law enforcement
- Enable cutting-edge scientific research
- Defend NOAA in litigation


